### Information on Temporary Emergency Surcharges Update for Week 17

Dear Sir or Madam,

we would like to inform you about the current surcharges effective from **April 20, 2026**.

#### Bunker (BAF)

The regular BAF surcharge according to the GUT scale is at level 45 in April 2026.

#### Temporärer Emergency-BAF

in addition, an **Emergency BAF** is charged, which is reviewed weekly and adjusted accordingly.

For inland waterway shipments in the period **from April 20, 2026** up to and including **April 26, 2026**, the following **temporary Emergency BAF** surcharge applies:

20' empty	20' full	40' empty	40' full
11,00€	16,00€	14,00€	23,00€

The decisive factor for the calculation is the departure date of the inland vessel from Gernsheim or from the respective seaport.

## Diesel Surcharge (Truck)

The standard diesel surcharge for the month of April is EUR 1.65 net. Accordingly, the truck diesel surcharges are calculated based on the following scale:

Any further increases will be applied in accordance with the table shown above.

## Emergency Diesel Surcharge (Truck)

For truck transport, we continue to charge an additional temporary **Emergency Diesel Surcharge** of a flat rate of EUR 5.00 per trip.

## Congestion Surcharge (Rail)

Due to ongoing capacity constraints, infrastructure measures, as well as operational limitations within the European rail network, there continue to be significant disruptions in rail transport and associated cost increases.

As the previous congestion costs are already included in our existing rates, **we are only passing on the difference as an additional surcharge.**

For rail transports, the following additional congestion surcharge will therefore apply from 01.05.2026:

- **20' container: EUR 5.00**
- **40' container: EUR 10.00**

The previously calculated congestion remains part of our rates.

The additional surcharge will be transparently shown as a separate Congestion Surcharge (Rail).

We continue to closely monitor the development of fuel prices and will regularly review the surcharges in line with market trends.

The remaining existing surcharges will initially remain unchanged.
